## **General Course Information:**

**Course Level:** Introductory

**Course Description:** An overview of the skills and knowledge necessary for the field of Cosmetology.

**End-of-Course Outcomes:** Demonstrate introductory skills, professional ethics, safety and sanitation. Explain the laws and rules of the state licensing agency.

**Specific Goals/Objectives of this course are to:**

- Exhibit the comprehensive of professional ethics.
- Demonstrate sanitation and safety practices.
- Explain the rules and regulations South Plains College, the Cosmetology department and the Texas Department of Licensing and Regulation.

**Course Competencies:** Upon successful completion of this course, the student will;

- Perform correct use of all sanitation and safety procedures mandated by the State, Institution and Cosmetology Department.
- Practice good personal and professional ethics.
- Comply with the Texas Department of Licensing and Regulation, South Plains College and the Cosmetology Department rules and regulations.
- Demonstrate habits of proper safety and hygiene for the interest of one's self and other's.
- Demonstrate the pursuit of daily personal improvement.

**Academic Integrity:**

It is the aim of the Cosmetology faculty of South Plains College to foster spirit of complete honesty and a high standard of integrity. **Verification of Workplace Competencies:** Successful completion of this course permits qualified students to enroll for specifically restricted skill course that can lead to Texas Department of Licensing and Regulation operator’s Licensure. Students who do not meet criteria for restricted enrollment will be counseled regarding their workplace competencies and career goals/objectives.

**Specific Course/Instructor Requirements:**

4. Milady’s Standard Practical Workbook.

**Attendance Policy:**

Punctual and regular attendance is required of all Cosmetology students. Unexcused tardiness and absences will not be tolerated. A doctor's note stating that it is acceptable to return to school in cases of contagious diseases such as pink eye, strep throat or the flu. But if 20% of this course is missed without a doctor's note the student will be encouraged to drop this course. If the student refuses to drop then the instructor of this course will do a mandatory drop.

**Assignment Policy:**

All required work must be turned in on time in order that the student may benefit from the corrections and future examinations. Assigned outside work is due on the class period assigned. Late work is generally not acceptable; however special consideration is subject to instructor discretion whether or not the work is acceptable.

**Grading policy/Procedure/Methods of Evaluation:**

See the General Catalog "Grades and Reports" for explanation of grades and grade point averages. The course instructor will introduce the college grading policy and method to determine G.P.A. during the course of instruction. The Texas Department of Licensing and Regulation demands an overall minimum grade of 70; therefore this course requires the same. An overall grade below 70 is considered an F.

**Special requirements/Safety Policy:**

Students shall adhere to the safety standards established by the Texas Department of Licensing and regulation, South Plains College and the Cosmetology handbook. Students in Cosmetology must follow all safe practices in laboratory work areas, other specific topics (dress code, cell phones, etc.) refer to the cosmetology Handbook.

- Demonstrate basic manipulative skills required to enter the field of Cosmetology.
- Possess a knowledge, understanding, skill, and appreciation of the theory and practice of basic cosmetology.
- Demonstrate habits of proper safety and hygiene for the interest of one's self and others.
- Demonstrate habits of good workmanship and orderly performance of fundamental skills.
- Perform professional communication skills.
- Possess a professional attitude towards patrons, fellow workers, employers and the general public.
